As per the Memorandum of Understanding dated 24.07.2017 executed and signed by and between.

Late Pratyush Bhartia, Mrs. Manju Bhartia, W/o. of Late Pratyush Bhartia, Mr. Gaurang Bhartia, Director and Son of Late Pratyush Bhartia, Mr. Raghav Bhartia And M/s. Puran Associates Private Limited and M/s. Save & Prosper Limited (Share holding of the company).

Whereas the first party being the shareholders of M/s. Save & Prosper Limited have sold their entire shareholding to the extent of 99.83% in the said company to the second party i.e. M/s. Puran Associates Private limited for Rs.1,18,00,00,000/- (Rupees One Hundred and Eighteen Crores Only) and the sale consideration was paid by the second party to the first party as under:

- Rs. 14,78,82,769/- to PNB against the financial assistance availed by the M/s. Circar Jute mills Private Limited, the sister concern of the first party from the said Bank and the title documents of the said property have been deposited by the third party with the said Bank.
- Therefore out of the total sale proceeds, Rs.14,78,82,769/- was deposited with the PNB and the remaining amount of Rs.103,21,17,231/- was paid by the second party to the first party as per their share holdings.
- Out of Rs.103,21,17,231/- an amount of Rs.63,84,88,231/- was received by the Directors / Guarantors of our NPA Borrower company M/s. Circar Jute Mills Private Limited during 2017 (viz. Late Pratyush Bhartia, Mrs. Manju Bhartia, Mr. Gaurang Bhartia). Even after receiving the huge amount, they have failed to repay our Book dues.

Thus the Borrower/Guarantors have defaulted in meeting its payment / repayment obligations to the lender even when they have the capacity to honour the said obligations.
