FAIR SUMMARY OF PROCEEDINGS OF THE 17TH ANNUAL GENERAL MEETING OF SIRCA PAINTS INDIA LIMITED HELD ON JULY 25, 2022 AT 12:30 P.M. THROUGH VIDEO CONFERENCING ("VC") / OTHER AUDIO-VISUAL MEANS ("OAVM")

The 17th Annual General Meeting ("AGM") of the Members of Sirca Paints India Limited (the "Company") was held through video conferencing VC/ OAVM on Monday, July 25, 2022. The 17th AGM of the Company was commenced at 12:30 P.M. (IST) and concluded at 01:09 P.M. (IST). The requisite quorum being present, the Chairman called the meeting in order and commenced the proceedings of the meeting. All the directors of the Company were present in the meeting except Mr. Ugo Pelosin, Mr. Sanjay Kapoor and Mr Anil Kumar Mehrotra, who are unable to attend the meeting due to exigencies. the Board of Directors and Management of the Company introduced themselves to the members.

The Members were informed that necessary Statutory Registers and other certificates and documents as required by law were open for inspection during continuance of the meeting at the website of the Company i.e. www.sircapaints.com and portal of KFin Technologies Limited ("KFintech"). The Members were also informed that Auditor's Report on standalone and consolidated financial statements of the Company for the financial year ended March 31, 2022 did not contain any qualification and observation or comment which have any adverse effect on the functioning of the Company. Further, Secretarial Audit Report for the financial year ended March 31, 2022 did not contain any qualification and observation or comments which have any adverse effect on the functioning of the Company. Mr. Sanjay Agarwal, Chairman cum Managing Director delivered his speech. Further, Mr. Apoorv Agarwal, Joint Managing Director extended a very warm welcome to the shareholders, Board of Directors and invitees, then, gave his address to the members on performance of the Company for the financial year 2021-22 and the future outlook of the industry as well as the Company.

Consequently, the items proposed in the notice convening the 17th AGM were briefed to the members. Thereafter, detailed clarifications were provided to all the queries raised by the members.
